Electronic Visit Verification – Affected Services**



As of January 1, 2021, providers delivering certain in-home services to participants in five of Kentucky’s six 1915(c) Home and Community Based Services (HCBS) waivers are required to use electronic visit verification or EVV. The affected waivers are:

EVV is an application used to collect information about in-home service delivery including the type, location, date, and start and end time of the service, the name of the individual delivering the service, and the name of the individual receiving the service.

A listing of affected services by waiver is below. In August 2023, Netsmart switched from using waiver descriptions for each code to the industry standard short and long descriptions. The listing includes the service, the code, and the industry standard short and long descriptions of each code.
