Recently you received a letter from the Department of Medicaid Services regarding Substance abuse services provided through the early and periodic screening, diagnosis and treatment (EPSDT) program.

In an effort to further clarify and assist providers in the provision of EPSDT services. The Cabinet for Health and Family Services will be offering a Summit on **October 7th and 8th, 2013.** The first day will focus on reimbursement of substance use services for adolescents with substance use disorders.
