## KIPDA District Determination

The KIPDA District has scored in the **NEEDS ASSISTANCE** category.

A determination of **NEEDS ASSISTANCE** means that the district must seek out targeted technical assistance and training resources on areas of non-compliance. This may include onsite technical assistance visits and monthly monitoring calls with the Point of Entry Manager and other key stakeholders.

Indicators 1, 7 and 8 are compliance indicators. The target is set by the Office of Special Education Programs (OSEP).
