**INSTRUCTIONS FOR FORM**

1. **Vendor Number** - Enter the authorized WIC Vendor Number as it appears on the Vendor Stamp. A vendor applicant will leave the area blank.
2. **Date Completed** - Enter the numerical month, day and year on which you are completing the Price List. For example, May 1, 2009=050109
3. **Name of Store** - Print the name of the store.
4. **Signature of Store Contact** - Signature of person providing information. Review the instructions for the form, paragraphs 7 and 8, prior to completing and signing the form.
5. **Title of Store Contact** - Title of person providing information.
6. **Prices** - Complete prices for the WIC approved foods as requested below.

**PRICES ARE TO BE THE SHELF PRICES OF WIC APPROVED FOODS IN STOCK**

**Milk** - Enter the lowest price brand in stock by size.

**Cheese** - Enter the lowest price brand in stock by size. Prices must only be for 8 or 16 ounce sizes of cheese.

**Cereal** - Enter the highest price for each brand and size in stock.

**Eggs** - Enter the highest price charged for eggs.

**Juice** - Enter the highest price for each type, brand and size of juice in stock.

**Dry Beans or Peas** - Enter the highest price charged for a 1 pound bag of beans

**Canned Beans**- Enter the highest price charged for a 16 oz. can as specified.

**Peanut Butter** - Enter the highest price charged for an 18 oz. size of peanut butter.

**Whole Grain Bread** – Enter the highest price charged for each brand and size in stock.

**Whole Grain Products**- Enter the highest price charged for each brand and size in stock.

**Tuna/ Salmon/ Sardines** - Enter the highest price charged for each brand and size in stock.

**Infant Cereal** - Enter the highest price charged for an 8 oz. box of infant cereal.

**Infant Meats** - Enter the highest price charged for a 2.5 oz. container.

**Infant Fruits and Vegetables**- Enter the highest price charged for a 4.0 oz. container.

**Infant Formula** - Enter the highest price for each type and size in stock.

7. I do hereby certify that the items listed on this form were available at the store indicated and the prices entered were the actual shelf price. I understand this information is to be used to judge my inventory as set forth in the WIC Program Vendor Agreement item 1(b), is used in the review of prices charged on WIC food instruments and is used to judge commensurate pricing as set forth in the Vendor Agreement. I understand that if my contract is terminated or non renewed for commensurate pricing, failure to meet inventory or failure to properly mark the price of WIC food items, I cannot reapply for sixty (60) days from the day that I return my stamp for the first occurrence. A second occurrence will result in a 120 day disqualification and a third occurrence will result in a one (1) year disqualification.
