# 20<sup>th</sup> Annual Governor's Service Awards

## General Information and Category Criteria

### General Information and Eligibility Guidelines

- The Governor's Service Awards program, formerly called the Governor's Awards for Volunteerism and Service, is administered by the nonpartisan Kentucky Commission on Community Volunteerism and Service (KCCVS) to highlight the importance of volunteer and national service in Kentucky. - All required information – nomination form, narrative questions and letter(s) – must be completed and submitted by the deadline to be eligible for consideration.
- These awards honor **service completed during 2014**, and the awards ceremony for winners will be held at the Governor's Mansion in Frankfort in late spring/early summer 2015.
- Nominators will be notified of the results of their nominee(s). Winning nominators are notified by phone by April 6, 2015. All other nominators are notified by mail by April 30, 2015.
- Individuals and groups may be nominated in only **one** category. Self-nominations are accepted.
- Members and staff of the KCCVS, its awards committee and judges are not eligible to nominate or be nominated.
- Individuals or groups who volunteer as part of work-release and/or for course credit are eligible. However, they may not receive compensation other than reimbursement of out-of-pocket expenses to be eligible for this awards program.
- A member of national service programs in Kentucky (e.g. AmeriCorps, AmeriCorps VISTA, Senior Corps programs such as RSVP, FGP and SCP) is eligible **only** in the National Service category.
- Governor's Award recipients from the previous five years are not eligible for the 2014 awards program. A list is available on the KCCVS website.
- With the exception of the Lifetime Achievement Award and the Volunteer Coordinator Award, nominations must **focus** on service activities that occurred during **Jan. 1-Dec. 31, 2014**.
- With the exception of the Kentucky Ambassador Award, volunteer service must have been performed in **Kentucky**, serving primarily Kentuckians.
- Information from nominations may be released to the media and elected officials.

### Judging and Submission Information

- A panel of judges with experience in volunteerism and/or national service carefully reviews all complete nominations.
- Nominations are scored using the assigned judging worksheet, which is available to view on the KCCVS website.
- In the event multiple nominations are submitted for the same nominee, the judging panel considers the average score of all nominations.
- The judging panel reserves the right to award one or more honorees in a category. The panel may also opt not to issue awards in a category.
- The decisions of the judging panel are final.
- Electronic submission is encouraged, but nominations are also accepted by mail.
- Confirmation of receipt will be sent via email within five business days.
- Completed nomination packets must be received via email or postmarked **by midnight on Wednesday, Feb. 18, 2015**.

## **Award Categories and Criteria**

*Special consideration may be given to nominations covering one or more of the following six national focus areas: disaster services, economic opportunity, education, environmental stewardship, healthy futures, and veterans and military families. **Senior Volunteer Service Award:** Recognizes an individual (ages 65 and older) who has met a community need in an innovative and effective manner. The nominee may have made an impact through changed lives and/or community conditions as a result of service efforts.

**Volunteer Service Award:** Recognizes an individual (ages 19-64) who has met a community need in an innovative and effective manner. The nominee may have made an impact through changed lives and/or community conditions as a result of service efforts.

**Youth Volunteer Service Award:** Recognizes a youth (ages 18 or younger) who has demonstrated significant contributions to volunteer efforts/programs. The nominee may serve as a role model and inspiration to other volunteers.

**Veteran Volunteer Service Award:** Recognizes a veteran who has met a community need beyond his/her military service duties.

**Group Volunteer Service Award:** Recognizes a group of individuals or organizations that come together on their own to make a difference in their community. This may be a one-time service project or ongoing effort. Examples of groups include honor societies, leadership groups, boy/girl scouts, clubs and teams.

**Faith-Based Group Award:** Recognizes a group that volunteers through a faith-based community organization, serving populations outside of the organization. The nomination should demonstrate significant volunteer outreach.

**Challenge Award:** Recognizes an individual who has overcome significant personal obstacles in order to engage in volunteer service. These obstacles may include anything from physical and/or mental challenges to significant time constraints.

**Volunteer Coordinator Award:** Recognizes a paid or volunteer manager who exemplifies solid volunteer management skills, such as in volunteer training, risk management, screening, recognition, evaluation and retention of volunteers.

**National Service Award:** Recognizes an individual member and/or group of members of a national service program (AmeriCorps, AmeriCorps VISTA, AmeriCorps NCCC or Senior Service Corps) who have demonstrated service beyond standard expectations of the designated program. This individual and/or group provides an extraordinary example of the National Service spirit.

**Corporate Award:** Recognizes a business that has made an impact through innovation, volunteer hours, number of volunteers, monetary support, etc. It may recognize the historical record of supporting volunteerism through policies and practices. The nomination should demonstrate ongoing community or statewide impact.

**Nonprofit Organization Award:** Recognizes a nonprofit organization that manages an exceptional volunteer program that has made a significant impact on the community.

**Lifetime Achievement Award:** Recognizes a lifelong commitment to volunteerism and community service at a variety of levels. Nominees must have made a substantial and sustained impact in the community as a result of their service efforts.

**Kentucky Ambassador Award:** Recognizes a Kentuckian whose primary volunteer service is outside of Kentucky and/or the United States, promoting Kentucky as a "Commonwealth of Caring."

**First Lady's Award:** Recognizes a Kentuckian of any age who has assisted at-risk students in their efforts to reach educational goals, leading to graduation. This may have been done through mentoring, time spent tutoring or advising, or by working directly with a school. Examples include peer tutors, literacy coaches, postsecondary education advisors and retired teachers.
