Equity, Social and Economic Justice

P-EBT Update

Pandemic Electronic Benefit Transfer (P-EBT) cards were issued by DCBS in partnership with the Kentucky Department of Education and sent to students enrolled in non-traditional instruction (NTI). Cards were sent in two "rounds," with the first reaching 541,000 of 651,000 NTI students believed to be eligible for benefits needed during the pandemic. All cards have been mailed as of Nov. 17, and all households should receive them by Nov. 30. Beneficiaries who do not need the assistance are encouraged to destroy the card or make an equivalent donation to their local food pantry.

The new version was rolled out this fall. This new system allows foster parents to retrieve their own training accounts soon after being entered into TWIST, providing faster access to our web-based training

Self-Care Corner - Practice Gratitude this Season


