Understanding CCBHC Rendering and Performing Provider Edits

For some behavioral health services/procedures, the performing (face-to-face) provider can be someone who is not an enrolled Medicaid provider but is an associate level or have appropriate training/certification to perform the service. This performing provider's work must be directed /supervised by a licensed provider with an NPI and taxonomy registered with KY Medicaid Partner Portal.

NOTE: A provider modifier must be submitted on the service line to indicate the individual's skill/certification level when the services are not performed by the rendering provider enrolled with KY Medicaid.

Example:

LPAT Claim would have a rendering loop with a Name, NPI and Taxonomy of the registered provider LPAT Rendering: LPATA Service Line would have modifier U4 indicating Associate level Performing:
