### **These ordinary administrative regulations were filed on January 29, 2025**

#### **1. 907 KAR 16:005**

A. This administrative regulation was filed on January 29, 2025.

**B. Summary of Administrative Regulation:** This administrative regulation establishes the definitions for administrative regulations located in 907 KAR Chapter 16. Chapter 16 contains Medicaid administrative regulations regarding services provided to specific populations via 1915(i) state plan amendments.
