Amended After Comments version: The amended after comments version modifies the definition of BHA to include compliance with both supervision requirements of the collaborative educational agreement and compliance with billing supervision requirements for rendering Medicaid Services. The definition now includes that the BHA, except for a narcotic treatment program, must be in a graduate level program and be participating in an internship or practicum at an accredited educational institution. The regulation has been further amended to specify that the BHA cannot render a diagnosis for a client.
