

**Description and information about Administrative Regulations filed on July 1:**

**This emergency and ordinary administrative regulation were filed on July 1, 2022:**

**1. 907 KAR 1:065E**

A. This administrative regulation was filed on July 1, 2022

**B. Summary of Administrative Regulation:** This administrative regulation establishes reimbursement for nursing facilities participating in Kentucky Department for Medicaid Services for all non-managed care recipients.

This amendment incorporates the \$29 pandemic related reimbursement increase into this administrative regulation. The regulation is also amended to ensure that the \$29 reimbursement increase will be included in nursing facility base rates in the future.

D. A public hearing on this administrative regulation shall, if requested, be held on August 22, 2022, at 9:00 a.m. using the CHFS Office of Legislative and Regulatory Affairs Zoom meeting room. The Zoom invitation will be emailed to each requestor the week prior to the scheduled hearing. Individuals interested in attending this virtual hearing shall notify this agency in writing by August 15, 2022, five (5) workdays prior to the hearing, of their intent to attend. If no notification of intent to attend the hearing is received by that date, the hearing may be canceled. This hearing is open to the public. Any person who attends virtually will be given an opportunity to comment on the proposed administrative regulation. A transcript of the public hearing will not be made unless a written request for a transcript is made. If you do not wish to be heard at the public hearing, you may submit written comments on this proposed administrative regulation until August 31, 2022. Send written notification of intent to attend the public hearing or written comments on the proposed administrative regulation to the contact person.
