What is “Go-Live”?

- ❖ “Go-Live” means the Tellus EVV system is operational and traditional agencies and financial management agencies (FMAs) **can** begin using the EVV system to document and bill EVV-affected services.
- ❖ Go-Live for EVV in Kentucky is **November 17, 2020**.
- ❖ DMS encourages traditional agencies and FMAs to choose a small number of paid caregivers and participants to use EVV with during the go-live period.
 - This will allow traditional agencies and FMAs to get familiarized with the system, get questions answered and resolve issues **before the mandatory deadline** to use EVV of **January 1, 2021**.

Go-Live Prep – Participant and Families

Participant and Family Readiness Checklist

September 2020:

- Visit DMS EVV website and review meeting recordings
- Visit DMS EVV website and review FAQs
- Subscribe to DMS email updates
- Talk with your provider agency (for traditional services) and/or FMA (for PDS) to find out which EVV system it plans to use
- For PDS, discuss what EVV is with your employees
 - Figure what device(s) your employee(s) will use to access the Tellus EVV+ mobile app, if your FMA is using Tellus.

October 2020:

- For PDS, ask your employee(s) if they have attended training

November 2020:

- Begin to use EVV with your paid caregiver(s)

Provider Readiness Checklist



Things to continue doing or start doing now:

- Visit DMS EVV website and review meeting recordings
- Visit DMS EVV website and review FAQs
- Subscribe to DMS email updates
- Discuss EVV with employees
- Talk to your participants about EVV
- Begin to gather email addresses for all employees

September 2020:

- Look for emails on training (check spam and junk folders)
- If using a third-party EVV system:
 - Stay in communication with vendor regarding integrations
 - Ensure third-party completes testing

Go-Live Prep - October

Provider Readiness Checklist



October 2020 – Using Tellus System:

- Determine who will be the train the trainer or EVV subject matter expert
 - Determine which staff should attend each training module (Tellus EVV+ mobile app, administrative portal, and claims portal)
 - Develop process on how to train paid caregivers and additional administrative staff
 - Ensure staff participate in training
 - Develop a communication process for staff when they have system and training questions

- Register to use the Tellus EVV system – registration opens October 30, 2020
 - Confirm ability to log into Tellus administrative portal

Provider Readiness Checklist



October 2020 – Using Third Party Vendor:

- Register to use the Tellus EVV claims portal - registration opens October 30, 2020
- Talk to your vendor to ensure they have completed integration and testing
- Download the necessary vendor-specific software and/or apps for EVV
- Receive and test login credentials for accessing the vendor-specific software
- Make a plan to attend Tellus EVV claims portal training
- Register for and complete third-party vendor training if needed
- Ensure your vendor processes the Tellus response file and provides you with the response file.

Go-Live Prep - November

Provider Readiness Checklist



November 2020 and beyond:

- If using Tellus EVV, have:
 - Employees download the Tellus EVV+ mobile app
 - Employees register for and test login credentials for the Tellus EVV+ mobile app

Other tasks for all provider agencies

- Download Tellus and third-party user guides (if applicable)
- Review training videos as needed
- Ask questions
- Begin using EVV
