***Assessment/Reassessment (MPW):** This service is noted in the waiver application. It is an administrative function that is provided through contracts with the state's community mental health centers (CMHCs). This function will continue through the same entity.

*Several services included in current MPW application were never approved through the regulatory process and thus were never available to use. They have been removed from the proposed MPW amendment to provide an accurate service menu.
