

What Does This Mean to Me? Michelle P. Waiver (MPW) Amendment August 2024

The Kentucky Department for Medicaid Services (DMS) completed a rate methodology study for most of its waiver services.¹ As a result of this study, DMS is making amendments to all six 1915(c) waivers. In the Michelle P. waiver, the changes in Appendix C relate to service units, the changes in Appendix I relate to updated rate methodologies, and the changes in Appendix J relate to updated cost estimates. To make changes to rates, DMS must hold a public comment period of at least 30 days before submitting the Michelle P. waiver amendment to CMS for approval.

To assist stakeholders in reviewing the waiver applications and making a public comment, we have included the key proposed updates included in the waiver application below. The full waiver application is available on the DMS Division of Long-Term Services and Supports website at https://bit.ly/KYMedicaidLTSSInfo. Instructions for submitting public comments are available in the public comment notice.

DMS recognizes that the current MPW application document includes services that are not currently funded and / or available to participants per Kentucky Administrative Regulation. These services include Community Access, Community Guide, Community Transition, Consultative Clinical and Therapeutic Services, Natural Supports Training, Person Centered Coaching, Shared Living, Specialized Medical Equipment and Supplies, and Vehicle Adaptations. DMS is required to keep these services in the waiver application document temporarily to comply with federal Maintenance of Effort requirements as defined in Section 9817 of the American Rescue Plan Act.

Once the Maintenance of Effort requirements have expired, DMS plans to remove these services to address any potential stakeholder confusion. This proposed amendment will not change the list of services that are funded and / or currently available to waiver participants, including Community Living Supports.
