

Administrative Regulations Notice

July 2022

The Department for Public Health filed the following amended administrative regulation with the Legislative Research Commission (LRC). The amendment to this administrative regulation is available on the LRC website <https://apps.legislature.ky.gov/law/kar/titles/901/005/>.

- **901 KAR 5:120. Abortion reporting.** The amendment to this administrative regulation was filed an emergency amendment and an identical ordinary amendment. Both the emergency and ordinary amendment update the abortion reporting criteria and update the material incorporated by reference. The emergency and ordinary amendment were necessary to implement the expanded reporting requirements in House Bill 3 from the 2022 legislative session.

Details for the public hearing on the **emergency amendment** are as follows:

A public hearing on this administrative regulation shall, if requested, be **held on August 22, 2022, at 9:00 a.m.** using the CHFS Office of Legislative and Regulatory Affairs Zoom meeting room. The Zoom invitation will be emailed to each requestor the week prior to the scheduled hearing. Individuals interested in attending this virtual hearing shall **notify this agency in writing by August 15, 2022**, five (5) workdays prior to the hearing, of their intent to attend. If no notification of intent to attend the hearing is received by that date, the hearing may be canceled. This hearing is open to the public. Any person who attends virtually will be given an opportunity to comment on the proposed administrative regulation. A transcript of the public hearing will not be made unless a written request for a transcript is made. If you do not wish to be heard at the public hearing, you may **submit written comments on this proposed administrative regulation until August 31, 2022**. Send written notification of intent to attend the public hearing or written comments on the proposed administrative regulation to the contact person. Pursuant to KRS 13A.280(8), copies of the statement of consideration and, if applicable, the amended after comments version of the administrative regulation shall be made available upon request.

Details for the public hearing on the **ordinary amendment** are as follows:

A public hearing on this administrative regulation shall, if requested, be **held on September 26, 2022, at 9:00 a.m.** using the CHFS Office of Legislative and Regulatory Affairs Zoom meeting room. The Zoom invitation will be emailed to each requestor the week prior to the scheduled hearing. Individuals interested in attending this virtual hearing shall **notify this agency in writing by September 19, 2022**, five (5) workdays prior to the hearing, of their intent to attend. If no notification of intent to attend the hearing is received by that date, the hearing may be canceled. This hearing is open to the public. Any person who attends virtually will be given an opportunity to comment on the proposed administrative regulation. A transcript of the public hearing will not

be made unless a written request for a transcript is made. If you do not wish to be heard at the public hearing, you may **submit written comments on this proposed administrative regulation until September, 2022**. Send written notification of intent to attend the public hearing or written comments on the proposed administrative regulation to the contact person. The Department for Public Health filed the following new administrative regulations with the Legislative Research Commission (LRC).

- **901 KAR 5:130. Certificate of abortion.** This new administrative regulation establishes the requirements for requesting a certificate of abortion and incorporates by reference the certificate worksheet form.
- **901 KAR 5:140. Permit to transport fetal remains.** This new administrative regulation establishes the process to request a permit to transport fetal remains and incorporates by reference the permit request form.

- **902 KAR 21:040. Community health worker certification.** This new administrative regulation establishes the initial and renewal certification process for certified community health workers including the process for certification suspension and revocation, and outlines the core competencies and scope of practice.
