"Abuse of authority" means an arbitrary and capricious exercise of authority that is inconsistent with the mission of the executive agency concerned or the successful performance of a contract of such agency.

"Inspector General" means an Inspector General appointed under the Inspector General Act of 1978 and any Inspector General that receives funding from, or has oversight over contracts awarded for, or on behalf of, the executive agency concerned.

3.908-3 Policy.

- (a) Contractors and subcontractors are prohibited from discharging, demoting, or otherwise discriminating against an employee as a reprisal for disclosing, to any of the entities listed at paragraph (b) of this subsection, information that the employee reasonably believes is evidence of gross mismanagement of a Federal contract, a gross waste of Federal funds, an abuse of authority relating to a Federal contract, a substantial and specific danger to public health or safety, or a violation of law, rule, or regulation related to a Federal contract (including the competition for or negotiation of a contract). ANNUAL PERFORMANCE REPORT: Awardee describes continued efforts with initiatives to improve tobacco control despite limited resources. Awardee successfully implemented bidirectional referrals to large healthcare organizations while improving e-referrals for tobacco users. Awardee provided outreach and education to 25 healthcare providers on the 5 As (Ask, Advise, Assess, Assist, Arrange) pregnancy/postpartum protocols and Quit Now Kentucky as a referral source. Awardee effectively created and ran media campaigns via television, radio and digital platforms with the focus on quitting tobacco resources. **Key Strengths** Awardee demonstrates effective work with schools and local health departments to increase the percentage of schools to incorporate tobacco free school policy. Awardee provided funding and established training to local health departments to assist public housing authorities with U.S. Housing and Urban Development smoke free ruling. Kentucky legislature passed a bill that significantly increased evidence-based tobacco cessation treatment to residents. The program has been instrumental in educating public and private health insurers on Food and Drug Administration approved tobacco cessation medicines and services recommended by the U.S. Preventive Services Task Force with no copays or barriers. Awardee omitted activity status for eliminating nonsmokers' exposure to secondhand **Key Weaknesses** smoke (goal 2, strategy 3) - increasing policies for smokefree multi-unit housing.
