**CHARACTERISTICS OF THE CLASS:** CHARACTERISTICS OF A CLASS ARE GENERAL STATEMENTS INDICATING THE LEVEL OF RESPONSIBILITY AND DISCRETION OF POSITIONS IN THAT JOB CLASSIFICATION.

Performs work of a moderate difficulty in the program, entry-level nursing functions and services to individuals and families under close supervision in a home health. The nurse in this classification would receive job specific training in the requirements and scope of practice of the various assigned health department programs and services.

**MINIMUM REQUIREMENTS:** MINIMUM REQUIREMENTS ARE COMPREHENSIVE STATEMENTS OF THE MINIMUM BACKGROUND AS TO EDUCATION, EXPERIENCE, AND OTHER QUALIFICATIONS WHICH WILL BE REQUIRED IN ALL CASES AS EVIDENCE OF AN APPOINTEE'S ABILITY TO PERFORM THE WORK PROPERLY.

Delegates basic nursing services to LPN I nurses and unlicensed assistive personnel, such as home health aides and clinical assistants. May evaluate and monitor client progress reports prepared by other licensed practical nurses. Works closely with the RN and physicians to ensure the coordination of services and proper implementation of nursing care and treatment plans, describes services that are available and eligibility criteria as appropriate, participates in the development and implementation of plan(s) of care on the health risks identified during the nursing assessment and provides basic nursing care under supervision to the client based on determined needs. May supervise LPN I nurses, unlicensed assistive personnel and support staff. Initiates appropriate teaching and demonstration of care for individual clients and families based on nursing assessment with an emphasis on the promotion, maintenance, and restoration of health and self-care and participates in training related to job responsibilities.

**TYPICAL WORKING CONDITIONS AND UNIQUE PHYSICAL REQUIREMENTS:** INCUMBENTS IN THIS CLASSIFICATION WILL TYPICALLY PERFORM THEIR PRIMARY JOB DUTIES UNDER THESE CONDITIONS. THESE CONDITIONS MAY CHANGE ON OCCASION IN PERFORMING THE DUTIES OF AN INDIVIDUAL POSITION.

Work is spent primarily inside the clinic or community setting.
