Perform specialized medical duties in a local health department. May have immediate charge of a specific program involving specialization in a particular field of medicine which requires previous professional training.

**EXPERIENCE:** Two (2) years of experience in the practice of medicine or public health

**EDUCATION:** A MPH degree is equivalent to one (1) year of experience.

**EXPERIENCE:** The successful completion of an approved program of residency training in a recognized specialty or sub-specialty of medicine is equivalent to the two (2) years of experience on a year for year basis.

**SPECIAL REQUIREMENTS:** (AGE, LICENSURE, REGULATION, ETC.) Must be licensed to practice medicine in the Commonwealth (KRS 311.571, 311.560, and 311.580).

**POST EMPLOYMENT REQUIREMENTS**: EMPLOYEES IN THIS CLASS WILL BE REQUIRED TO OBTAIN CREDENTIALS OUTLINED BELOW WITHIN A REASONABLE TIME, OR IF EMPLOYEES POSSESS SUCH CREDENTIALS AT THE TIME OF HIRE THEY WILL BE REQUIRED TO MAINTAIN THOSE CREDENTIALS SO LONG AS THEY ARE EMPLOYED IN THIS CAPACITY.

Examine, diagnose, and treat patients. Confer with patients, families and family physicians when necessary. May attend and participate in medical staff conferences. Provide personal health, wellness services or procedures available to members of the community within the appropriate guidelines of medical specialty as prescribed by the Department for Public Health. Document case histories and perform follow-up work on progress of patients. Supervise care of patient and follow-up clinics.

May provide training or guidance on appropriate collection and use of patient data, public notification systems, complaint procedures, conflict resolution, customer service, compliance review techniques and resolution to noncompliance issues as applicable. Assure requirements for reasonable accommodations for person with disabilities, or need for language assistance is met. May supervise professional nursing staff, other health professionals and support staff.

TYPICAL WORKING CONDITIONS AND UNIQUE PHYSICAL REQUIREMENTS: INCUMBENTS IN THIS CLASSIFICATION WILL TYPICALLY PERFORM THEIR PRIMARY JOB DUTIES UNDER THESE CONDITIONS. THESE CONDITIONS MAY CHANGE ON OCCASION IN PERFORMING THE DUTIES OF AN INDIVIDUAL POSITION.
