


Outbreak Statistics (through 2-9-19)

- Total Cases: 4,091
- Number of counties with cases: 103 (86% of KY counties)
- Hospitalizations: **1,982** (48%)
- Deaths: **40*** (1%)
- Median Age: 36 years, Range: 1-84
- HAV genotype testing
 - 572 (91% of those tested) genotype IB



Outbreak Curve






^{*} Date of onset has been reported for 79.1% (or 3276/4091) of cases.

KY17-089 Distribution of Outbreak-Associated Acute Hepatitis A Cases by County, August 1, 2017 - February 9, 2019





Incidence Rate


KY17-089 Incidence of Outbreak-Associated Acute Hepatitis A Cases by County, August 1, 2017 - February 9, 2019

Risk Factor	Number of Cases Reporting Risk Factor (n=3316)* †
Homelessness + No/Unk Illicit Drug Use	54 (1.6%)
Illicit Drug Use + No/Unk Homelessness	2354 (71%)
Homelessness + Illicit drug use	279 (8.4%)
No Outbreak-Related Risk Factors	629 (19%)

^{*} Risk factor information is unavailable for 775 (18.9%) of all outbreak-associated cases.



[†] The categories below do not add up to the total number in this count due to other possible risk factor combinations not shown in the table

- DPH is working on establishing nurse strike team for vaccination events at jails
- Guidance requesting continued specimen submission to DLS and encouraging vaccination of at-risk population is being sent to providers
- DLS is working on ability to perform sequencing in-house
- Vital statistics will be reviewed biweekly to confirm reported number of HAV deaths is accurate

- All vaccines, private stock or 317, must be entered into the registry
- Reach out to schools and encourage compliance with vaccination regulations
- Access guidance documents on Google Drive or DPH website
- Continue to send specimens for genotyping
- Create notifications even if case not interviewed
