Thank you for your interest in the **2023 Annual Administrative Claims Data Report – Emergency Department**. This report covers the emergency department utilization by licensed Kentucky hospitals for the calendar year January 1, through December 31, 2023. The outpatient services records data submitted by hospitals as required by 900 KAR 7:030 – Data Reporting by Health Care Providers was used to produce the utilization information in this report. Emergency Department records are specifically identified by a service marker indicating an emergency department encounter.

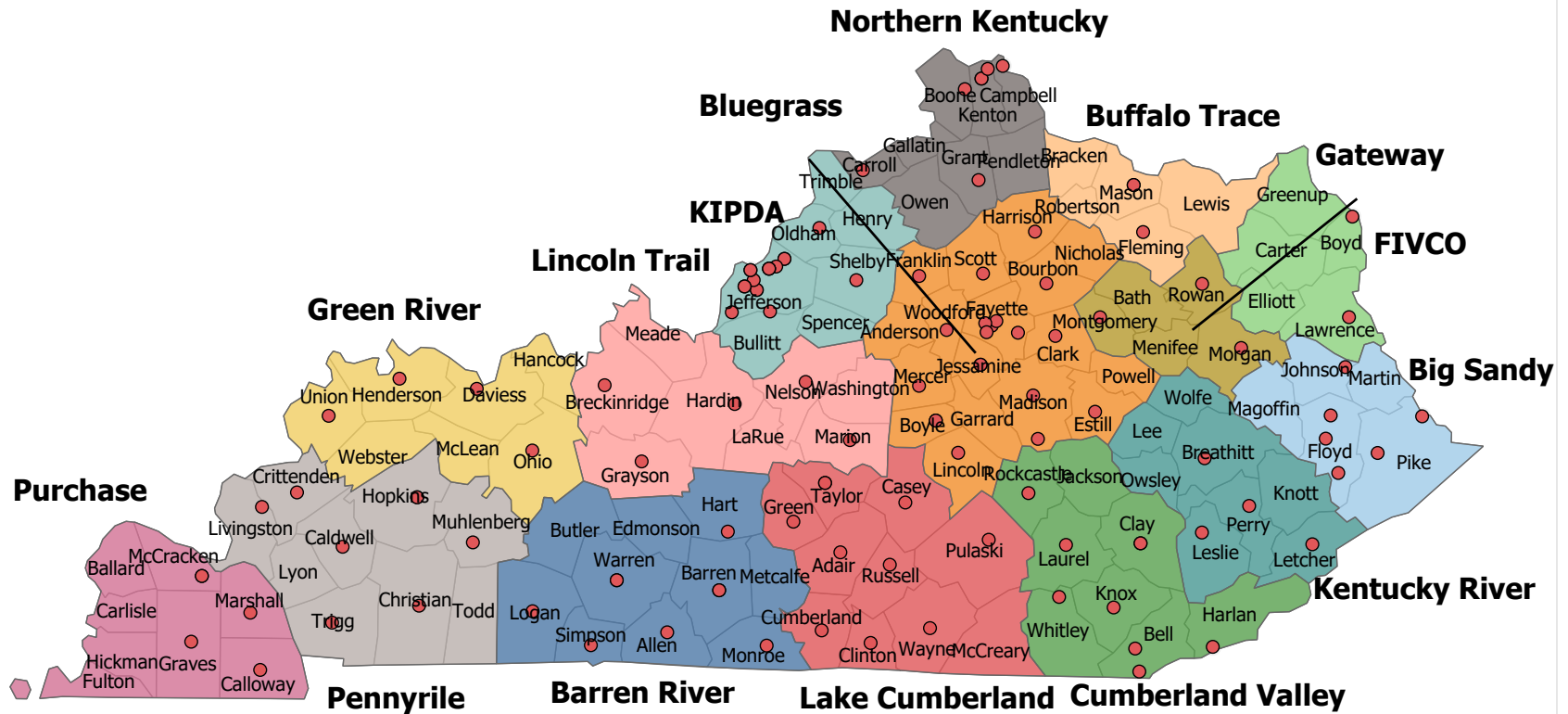

*Note: Facilities shown in geographic center of address zip code. Multiple facilities in close proximity (same zip code) may be designated with only one marker.

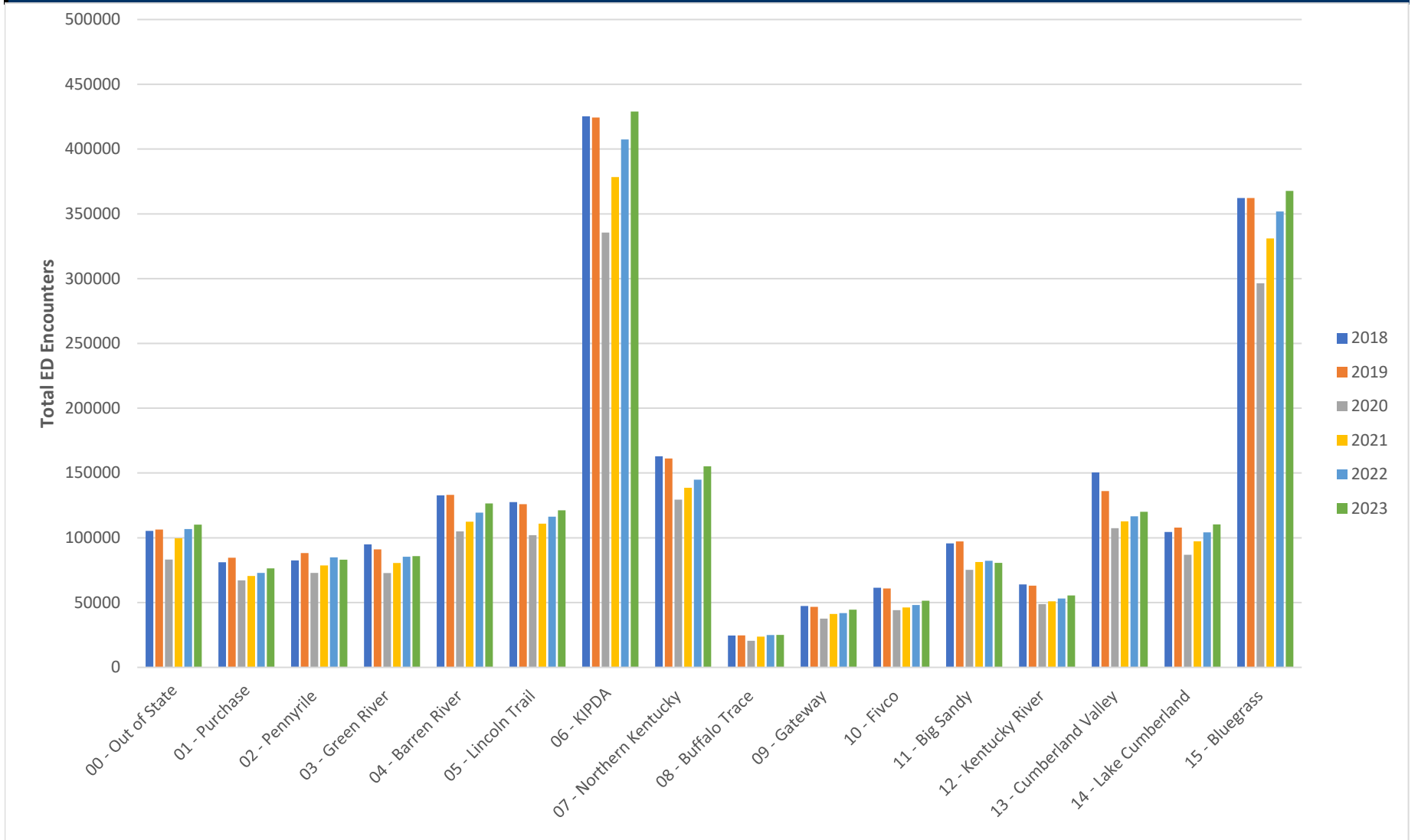

Chart 1 - ED Encounters by Year and Patient ADD

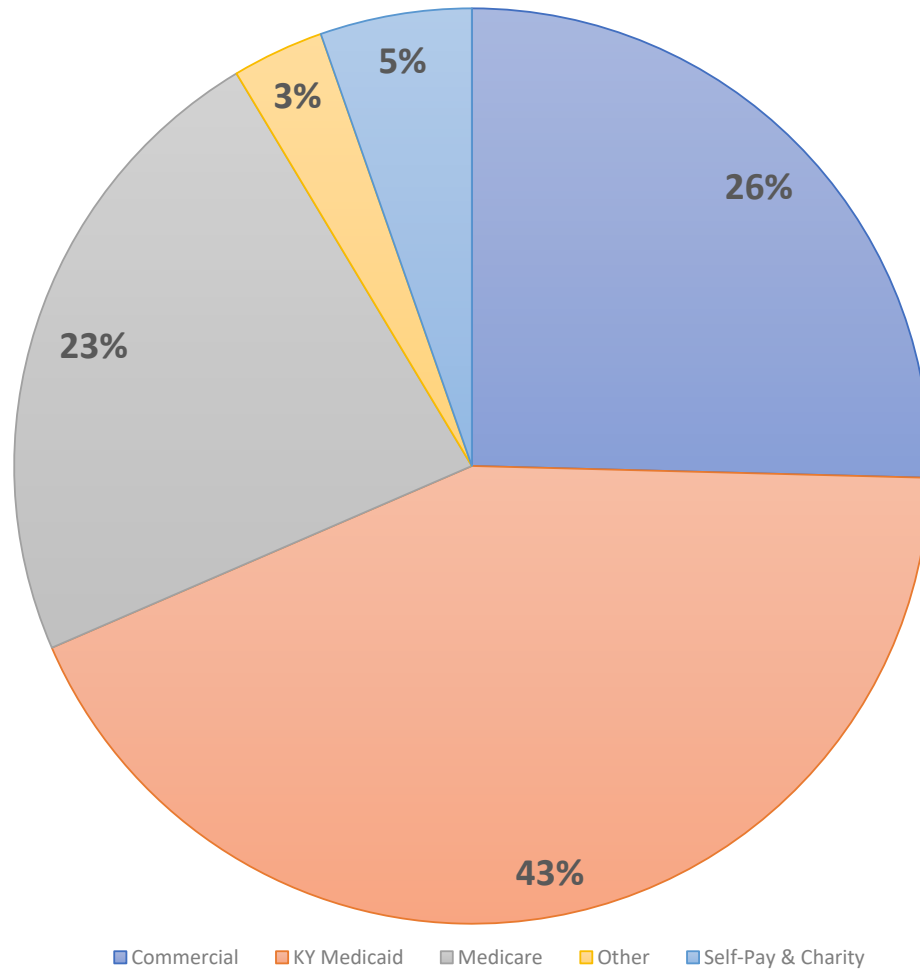

Chart 2 - Percent of ED Encounters by Primary Payor

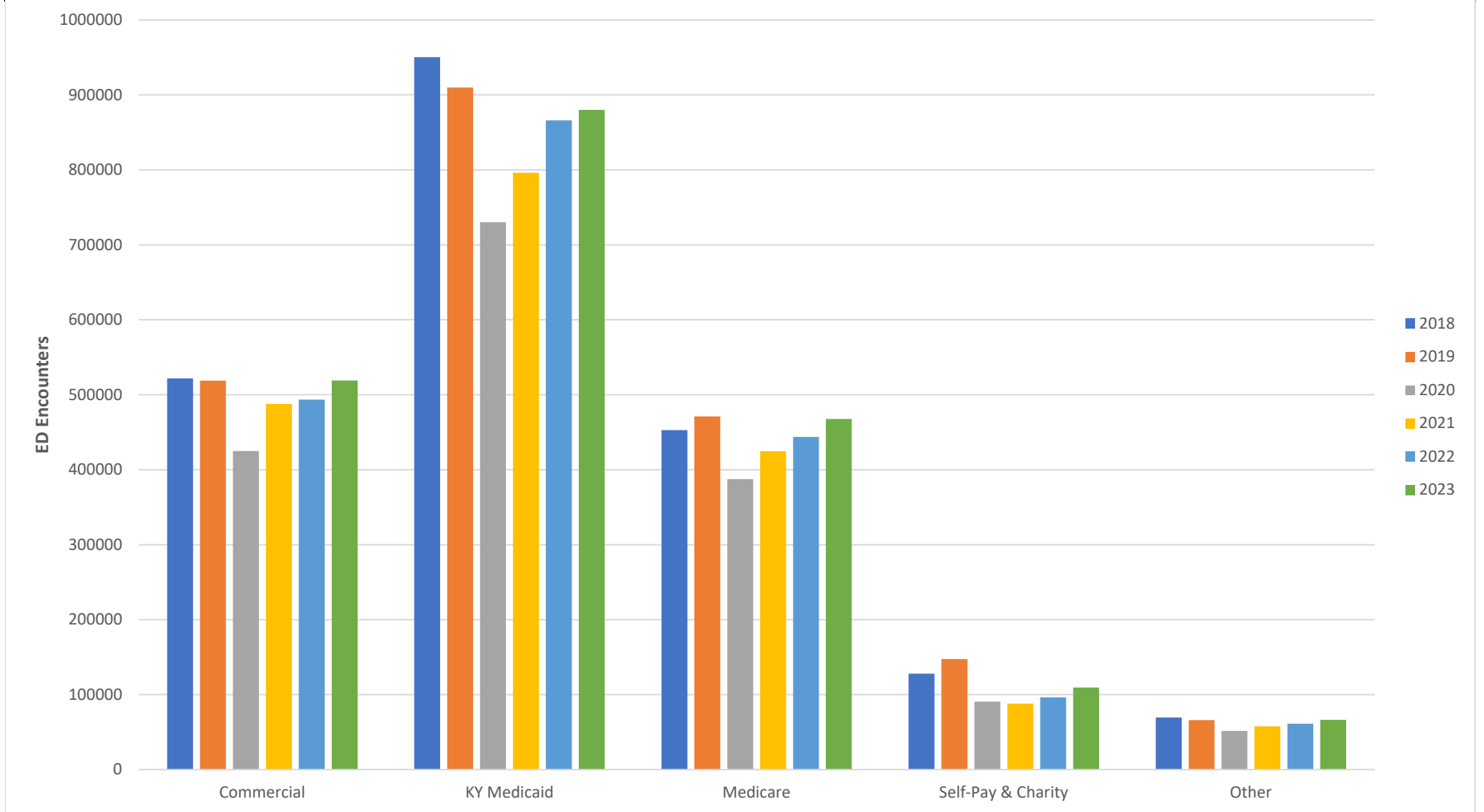
