

Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

AmeriCorps has 5 members in Ballard County.

Kentucky Transitional Assistance Program (KTAP)

Your county received \$58,020 in KTAP issuance. This has been allocated to 18 households in the past fiscal year.



On average, SNAP supported 824 people a month in Ballard County, stretching over 393 households.

Health Services

Funding to Purchase District Health Department: \$3,432,229

During fiscal year 2024, in Ballard county there were 2 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.



Your county has 225 participants who received benefits totaling \$205,835.

There are 1 WIC-approved grocers in Ballard County.

Division of Family Resource and Youth Services Centers (FRYSC)

Ballard County received \$118,524 in funding for 1 school district(s). The total student enrollment for schools served by FRYSC was 1,034, and 54% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$63,969.

Additional grants totaled \$0.

Ballard County received \$151,384 from the Child Care
Assistance Program issuance, supporting up to 44
providers a year.

The Division of Child Support Enforcement served 416 children, collecting \$637,595 in current and past due child support, during fiscal year 2024. The agency established 400 orders.

There were 27 children cared for by foster families, 26 of whom received a combined per-diem totaling \$1,875.

25% of children in foster care had a goal of adoption. 74% had a goal other than adoption (e.g. reunification).

Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 2,301 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 6,728 of the 17,181 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 563 prescribers and 106 dispenser DEA numbers.

Ballard County is served by the Four Rivers Community Mental Health Center. Four Rivers received \$7,247,573 in fiscal year 2024.

Four Rivers served 8,324 individuals in their region in fiscal year 2024.



Ballard is located in the Four Rivers region. This region received \$1,585,068 in Kentucky Overdose Response Effort (KORE) funding for fiscal year 2024.

Public Protection Services

The Office of the Ombudsman responded to 74 constituent contacts in fiscal year 2024 in your county.

The Office of Inspector General completed 128 background checks for children & elderly services in Ballard county fiscal year 2024.
