Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

Kentucky Transitional Assistance Program (KTAP)

Health Services

Funding to Bourbon County Health Department: \$1,173,449

During fiscal year 2024, in Bourbon county there were 9 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.



Your county has 460 participants who received benefits totaling \$410,836.

There are 2 WIC-approved grocers in Bourbon County.

Division of Family Resource and Youth Services Centers (FRYSC)

Bourbon County received \$428,512 in funding for 2 school district(s). The total student enrollment for schools served by FRYSC was 3,427, and 60% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$300,414. Additional grants totaled \$0.

Bourbon County received \$1,518,732 from the Child Care Assistance Program issuance, supporting up to 316 providers a year.

The Division of Child Support Enforcement served 903 children, collecting \$1,676,299 in current and past due child support, during fiscal year 2024. The agency established 907 orders.

There were 16 children cared for by foster families, 15 of whom received a combined per-diem totaling \$1,260.

62% of children in foster care had a goal of adoption. 37% had a goal other than adoption (e.g. reunification).

According to KASPER data, 6,344 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 18,452 of the 46,003 total controlled prescriptions dispensed.
