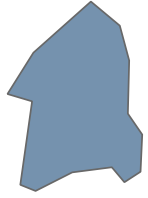

Kentucky**

Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

AmeriCorps has 21 members in Boyd County.

Kentucky Transitional Assistance Program (KTAP)

Your county received \$970,927 in KTAP issuance. This has been allocated to 273 households in the past fiscal year.

On average, SNAP supported 7,356 people a month in Boyd County, stretching over 3,554 households. Total SNAP spending in your county in fiscal year 2024: \$15,500,554

During fiscal year 2024, in Boyd county there were 26 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.



Your county has 1,115 participants who received benefits totaling \$1,098,993.

There are 5 WIC-approved grocers in Boyd County.

Division of Family Resource and Youth Services Centers (FRYSC)

Boyd County received \$722,386 in funding for 3 school district(s). The total student enrollment for schools served by FRYSC was 6,763, and 58% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$697,708. Additional grants totaled \$65,810.

Boyd County received \$798,882 from the Child Care Assistance Program issuance, supporting up to 304 providers a year.

The Division of Child Support Enforcement served 2,022 children, collecting \$2,488,220 in current and past due child support, during fiscal year 2024. The agency established 1,766 orders.

There were 181 children cared for by foster families, 108 of whom received a combined per-diem totaling \$10,166.

44% of children in foster care had a goal of adoption.
55% had a goal other than adoption (e.g. reunification).

Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 13,896 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 43,532 of the 105,546 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 2,213 prescribers and 327 dispenser DEA numbers.

Boyd County is served by the Pathways Community Mental Health Center. Pathways received \$7,882,552 in fiscal year 2024.

Pathways served 13,273 individuals in their region in fiscal year 2024.

 Boyd is located in the Pathways region. This region received \$2,007,623 in Kentucky Overdose Response Effort (KORE) funding for fiscal year 2024.

Public Protection Services

The Office of the Ombudsman responded to 525 constituent contacts in fiscal year 2024 in your county.

The Office of Inspector General completed 1,135 background checks for children & elderly services in Boyd county fiscal year 2024.
