Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

Kentucky Transitional Assistance Program (KTAP)

Your county received \$795,085 in KTAP issuance. This has been allocated to 220 households in the past fiscal year.

Funding to Bullitt County Health Department: \$889,367

During fiscal year 2024, in Bullitt county there were 40 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.

Division of Family Resource and Youth Services Centers (FRYSC)

Bullitt County received \$1,125,667 in funding for 1 school district(s). The total student enrollment for schools served by FRYSC was 12,964, and 47% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$405,222. Additional grants totaled \$5,346.

Bullitt County received \$4,022,113 from the Child Care Assistance Program issuance, supporting up to 824 providers a year.

The Division of Child Support Enforcement served 2,488 children, collecting \$5,185,567 in current and past due child support, during fiscal year 2024. The agency established 2,283 orders.

There were 163 children cared for by foster families, 106 of whom received a combined per-diem totaling \$13,319.

46% of children in foster care had a goal of adoption. 53% had a goal other than adoption (e.g. reunification).

Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 24,663 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 68,690 of the 166,515 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 4,488 prescribers and 487 dispenser DEA numbers.

Bullitt County is served by the Seven Counties Community Mental Health Center. Seven Counties received \$22,899,517 in fiscal year 2024.

Seven Counties served 24,161 individuals in their region in fiscal year 2024.



Bullitt is located in the Seven Counties region. This region received \$5,746,244 in Kentucky Overdose Response Effort (KORE) funding for fiscal year 2024.

Public Protection Services

The Office of the Ombudsman responded to 565 constituent contacts in fiscal year 2024 in your county.

The Office of Inspector General completed 47 background checks for children & elderly services in Bullitt county fiscal year 2024.
