Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

AmeriCorps has 7 members in Harlan County.

Kentucky Transitional Assistance Program (KTAP)

Your county received \$1,109,587 in KTAP issuance. This has been allocated to 277 households in the past fiscal year.

On average, SNAP supported 7,774 people a month in Harlan County, stretching over 3,746 households. Total SNAP spending in your county in fiscal year 2024: \$16,405,618

During fiscal year 2024, in Harlan county there were 7 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.

Division of Family Resource and Youth Services Centers (FRYSC)

Harlan County received \$625,488 in funding for 2 school district(s). The total student enrollment for schools served by FRYSC was 4,310, and 76% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$730,017. Additional grants totaled \$49,000.

Harlan County received \$624,645 from the Child Care Assistance Program issuance, supporting up to 176 providers a year.

The Division of Child Support Enforcement served 2,008 children, collecting \$2,124,930 in current and past due child support, during fiscal year 2024. The agency established 1,774 orders.

There were 12 children cared for by foster families, 8 of whom received a combined per-diem totaling \$955.

41% of children in foster care had a goal of adoption.
58% had a goal other than adoption (e.g. reunification).

Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 7,594 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 41,925 of the 81,704 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 1,674 prescribers and 264 dispenser DEA numbers.

Harlan County is served by the Cumberland River Community Mental Health Center. Cumberland River received \$6,306,135 in fiscal year 2024.

Cumberland River served 10,682 individuals in their region in fiscal year 2024.



Harlan is located in the Cumberland River region. This region received \$1,978,335 in Kentucky Overdose Response Effort (KORE) funding for fiscal year 2024.
