Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

Kentucky Transitional Assistance Program (KTAP)

During fiscal year 2024, in Henry county there were 9 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.

Division of Family Resource and Youth Services Centers (FRYSC)

Henry County received \$301,294 in funding for 2 school district(s). The total student enrollment for schools served by FRYSC was 3,052, and 48% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$131,757.

Additional grants totaled \$1,500.

Henry County received \$603,529 from the Child Care Assistance Program issuance, supporting up to 148 providers a year.

The Division of Child Support Enforcement served 715 children, collecting \$1,502,870 in current and past due child support, during fiscal year 2024. The agency established 792 orders.

There were 14 children cared for by foster families, 11 of whom received a combined per-diem totaling \$852.

14% of children in foster care had a goal of adoption. 85% had a goal other than adoption (e.g. reunification).

Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 5,116 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analysesics accounted for 13,925 of the 35,454 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 1,934 prescribers and 264 dispenser DEA numbers.

Henry County is served by the Seven Counties Community Mental Health Center. Seven Counties received \$22,899,517 in fiscal year 2024.

Seven Counties served 24,161 individuals in their region in fiscal year 2024.



Henry is located in the Seven Counties region. This region received \$5,746,244 in Kentucky Overdose Response Effort (KORE) funding for fiscal year 2024.

The Office of the Ombudsman responded to 237 constituent contacts in fiscal year 2024 in your county.

The Office of Inspector General completed 151 background checks for children & elderly services in Henry county fiscal year 2024.
