Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

AmeriCorps has 17 members in Johnson County.

### Kentucky Transitional Assistance Program (KTAP)

Your county received \$636,539 in KTAP issuance. This has been allocated to 162 households in the past fiscal year.



On average, SNAP supported 4,745 people a month in Johnson County, stretching over 2,295 households.

### **Health Services**

Funding to Johnson County Health Department: \$1,178,284

During fiscal year 2024, in Johnson county there were 11 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.



Your county has 531 participants who received benefits totaling \$527,628.

There are 3 WIC-approved grocers in Johnson County.

### Division of Family Resource and Youth Services Centers (FRYSC)

Johnson County received \$474,099 in funding for 4 school district(s). The total student enrollment for schools served by FRYSC was 3,894, and 61% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$551,343. Additional grants totaled \$15,144.

Johnson County received \$393,471 from the Child Care Assistance Program issuance, supporting up to 150 providers a year.

The Division of Child Support Enforcement served 1,240 children, collecting \$1,827,707 in current and past due child support, during fiscal year 2024. The agency established 1,226 orders.

There were 56 children cared for by foster families, 52 of whom received a combined per-diem totaling \$4,100.

32% of children in foster care had a goal of adoption. 67% had a goal other than adoption (e.g. reunification).

### Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 6,688 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 34,505 of the 70,615 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 1,538 prescribers and 289 dispenser DEA numbers.

Johnson County is served by the Mountain Community Mental Health Center. Mountain received \$7,419,535 in fiscal year 2024.

Mountain served 29,563 individuals in their region in fiscal year 2024.



Johnson is located in the Mountain region. This region received \$850,387 in Kentucky Overdose Response Effort (KORE) funding for fiscal year 2024.

### **Public Protection Services**

The Office of the Ombudsman responded to 256 constituent contacts in fiscal year 2024 in your county.

The Office of Inspector General completed 172 background checks for children & elderly services in Johnson county fiscal year 2024.
