

Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

AmeriCorps has 3 members in Laurel County.

Kentucky Transitional Assistance Program (KTAP)

Your county received \$1,327,017 in KTAP issuance. This has been allocated to 347 households in the past fiscal year.



On average, SNAP supported 11,667 people a month in Laurel County, stretching over 5,285 households.

Health Services

Funding to Laurel County Health Department: \$1,593,126

During fiscal year 2024, in Laurel county there were 20 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.



Your county has 1,473 participants who received benefits totaling \$1,614,331.

There are 8 WIC-approved grocers in Laurel County.

KPAP helped 141 patients in Laurel with 355 prescriptions to save a total of \$2,797,299 in prescription costs.

Division of Family Resource and Youth Services Centers (FRYSC)

Laurel County received \$1,037,038 in funding for 1 school district(s). The total student enrollment for schools served by FRYSC was 9,063, and 65% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$1,061,856. Additional grants totaled \$1,000.

Laurel County received \$1,093,760 from the Child Care Assistance Program issuance, supporting up to 342 providers a year.

The Division of Child Support Enforcement served 3,267 children, collecting \$4,457,430 in current and past due child support, during fiscal year 2024. The agency established 3,374 orders.

There were 160 children cared for by foster families, 120 of whom received a combined per-diem totaling \$10,326.

39% of children in foster care had a goal of adoption. 60% had a goal other than adoption (e.g. reunification).

Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 20,802 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 84,817 of the 186,252 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 3,004 prescribers and 451 dispenser DEA numbers.

Laurel County is served by the Cumberland River Community Mental Health Center. Cumberland River received \$6,306,135 in fiscal year 2024.

Cumberland River served 10,682 individuals in their region in fiscal year 2024.



Laurel is located in the Cumberland River region. This region received \$1,978,335 in Kentucky Overdose Response Effort (KORE) funding for fiscal year 2024.

The Office of Inspector General completed 684 background checks for children & elderly services in Laurel county fiscal year 2024.
