

Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

AmeriCorps has 30 members in Leslie County.

Kentucky Transitional Assistance Program (KTAP)

Your county received \$259,695 in KTAP issuance. This has been allocated to 76 households in the past fiscal year.



On average, SNAP supported 2,453 people a month in Leslie County, stretching over 1,165 households.

Funding to Kentucky River District Health Department: \$7,233,479

During fiscal year 2024, in Leslie county there were 3 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.



Your county has 411 participants who received benefits totaling \$386,479.

KPAP helped 97 patients in Leslie with 546 prescriptions to save a total of \$1,326,992 in prescription costs.

Division of Family Resource and Youth Services Centers (FRYSC)

Leslie County received \$250,831 in funding for 2 school district(s). The total student enrollment for schools served by FRYSC was 1,643, and 68% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$215,950.

Additional grants totaled \$22,000.

Leslie County received \$59,964 from the Child Care Assistance Program issuance, supporting up to 24 providers a year. The Division of Child Support Enforcement served 595 children, collecting \$692,590 in current and past due child support, during fiscal year 2024. The agency established 515 orders.

There were 15 children cared for by foster families, 12 of whom received a combined per-diem totaling \$1,248.

46% of children in foster care had a goal of adoption. 53% had a goal other than adoption (e.g. reunification).

Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 3,392 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 21,484 of the 39,146 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 1,007 prescribers and 185 dispenser DEA numbers.

Kentucky River served 3,769 individuals in their region in fiscal year 2024.



Leslie is located in the Kentucky River region. This region received \$2,141,273 in Kentucky Overdose Response Effort (KORE) funding for fiscal year 2024.

The Office of Inspector General completed 283 background checks for children & elderly services in Leslie county fiscal year 2024.
