Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

Kentucky Transitional Assistance Program (KTAP)

Your county received \$80,016 in KTAP issuance. This has been allocated to 26 households in the past fiscal year.

Health Services

Funding to Pennyrile District Health Department: \$3,632,698

During fiscal year 2024, in Livingston county there were 8 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.

Division of Family Resource and Youth Services Centers (FRYSC)

Livingston County received \$123,613 in funding for 2 school district(s). The total student enrollment for schools served by FRYSC was 1,050, and 57% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$241,516. Additional grants totaled \$4,025.

Livingston County received \$288,595 from the Child Care Assistance Program issuance, supporting up to 72 providers a year.

The Division of Child Support Enforcement served 364 children, collecting \$866,220 in current and past due child support, during fiscal year 2024. The agency established 303 orders.

There were 4 children cared for by foster families, 4 of whom received a combined per-diem totaling \$108.

0% of children in foster care had a goal of adoption.

100% had a goal other than adoption (e.g. reunification).

Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 3,570 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analysesics accounted for 11,678 of the 27,786 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 815 prescribers and 138 dispenser DEA numbers.

Livingston County is served by the Four Rivers Community Mental Health Center. Four Rivers received \$7,247,573 in fiscal year 2024.

Four Rivers served 8,324 individuals in their region in fiscal year 2024.



Livingston is located in the Four Rivers region. This region received \$1,585,068 in Kentucky Overdose Response Effort (KORE) funding for fiscal year 2024.

Public Protection Services

The Office of the Ombudsman responded to 61 constituent contacts in fiscal year 2024 in your county.

The Office of Inspector General completed 168 background checks for children & elderly services in Livingston county fiscal year 2024.
