


Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

AmeriCorps has 2 members in Marshall County.

Kentucky Transitional Assistance Program (KTAP)

Your county received \$486,343 in KTAP issuance. This has been allocated to 116 households in the past fiscal year.



On average, SNAP supported 2,669 people a month in Marshall County, stretching over 1,349 households.

Health Services

Funding to Marshall County Health Department: \$2,045,674

During fiscal year 2024, in Marshall county there were 5 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.



Your county has 685 participants who received benefits totaling \$560,774.

There are 4 WIC-approved grocers in Marshall County.

Between the start of the HIV Epidemic (1982) and June 2024, there were 34 diagnosed cases of HIV in your county.

Division of Family Resource and Youth Services Centers (FRYSC)

Marshall County received \$281,999 in funding for 1 school district(s). The total student enrollment for schools served by FRYSC was 1,705, and 68% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$762,457. Additional grants totaled \$149,000.

Marshall County received \$2,311 from the Child Care Assistance Program issuance, supporting up to 3 providers a year.

The Division of Child Support Enforcement served 633 children, collecting \$828,917 in current and past due child support, during fiscal year 2024. The agency established 649 orders.

There were 51 children cared for by foster families, 50 of whom received a combined per-diem totaling \$6,243.

53% of children in foster care had a goal of adoption. 46% had a goal other than adoption (e.g. reunification).

Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 3,814 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 17,867 of the 39,809 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 914 prescribers and 170 dispenser DEA numbers.

Marshall County is served by the Four Rivers Community Mental Health Center. Four Rivers received \$7,247,573 in fiscal year 2024.

Four Rivers served 8,324 individuals in their region in fiscal year 2024.



Marshall is located in the Four Rivers region. This region received \$1,585,068 in Kentucky Overdose Response Effort (KORE) funding for fiscal year 2024.

Public Protection Services

The Office of the Ombudsman responded to 242 constituent contacts in fiscal year 2024 in your county.

The Office of Inspector General completed 657 background checks for children & elderly services in Marshall county fiscal year 2024.
