Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

AmeriCorps has 3 members in Martin County.

Kentucky Transitional Assistance Program (KTAP)

Your county received \$126,945 in KTAP issuance. This has been allocated to 38 households in the past fiscal year.



On average, SNAP supported 2,806 people a month in Martin County, stretching over 1,282 households.

During fiscal year 2024, in Martin county there were 7 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.

Division of Family Resource and Youth Services Centers (FRYSC)

Martin County received \$431,693 in funding for 1 school district(s). The total student enrollment for schools served by FRYSC was 4,278, and 56% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$298,433.

Additional grants totaled \$0.

Martin County received \$604,347 from the Child Care Assistance Program issuance, supporting up to 174 providers a year.

The Division of Child Support Enforcement served 1,030 children, collecting \$1,725,330 in current and past due child support, during fiscal year 2024. The agency established 913 orders.

There were 110 children cared for by foster families, 72 of whom received a combined per-diem totaling \$3,647.

33% of children in foster care had a goal of adoption. 66% had a goal other than adoption (e.g. reunification).

According to KASPER data, 11,344 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 32,565 of the 85,274 total controlled prescriptions dispensed.
