


## **Mason County - Fiscal Year 2024**

Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

AmeriCorps has 0 members in Mason County.

#### Kentucky Transitional Assistance Program (KTAP)

Your county received \$482,703 in KTAP issuance. This has been allocated to 131 households in the past fiscal year.



On average, SNAP supported 3,058 people a month in Mason County, stretching over 1,430 households.

## **Health Services**

Funding to Buffalo Trace District Health Department: \$1,515,726

During fiscal year 2024, in Mason county there were 6 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.



Your county has 506 participants who received benefits totaling \$468,997.

There are 4 WIC-approved grocers in Mason County.

Between the start of the HIV Epidemic (1982) and June 2024, there were 32 diagnosed cases of HIV in your county. (NOTE: 2023 and 2024 data is considered preliminary)

### Division of Family Resource and Youth Services Centers (FRYSC)

Mason County received \$258,040 in funding for 2 school district(s). The total student enrollment for schools served by FRYSC was 2,699, and 61% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$175,290.

Additional grants totaled \$7,220.

Mason County received \$454,661 from the Child Care Assistance Program issuance, supporting up to 139 providers a year.

The Division of Child Support Enforcement served 1,150 children, collecting \$1,981,015 in current and past due child support, during fiscal year 2024. The agency established 1,151 orders.

There were 28 children cared for by foster families, 24 of whom received a combined per-diem totaling \$2,926.

35% of children in foster care had a goal of adoption. 64% had a goal other than adoption (e.g. reunification).

#### Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 4,773 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 11,092 of the 31,501 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 1,654 prescribers and 238 dispenser DEA numbers.

Comprehend served 2,207 individuals in their region in fiscal year 2024.



Mason is located in the Comprehend region. This region received \$593,282 in Kentucky Overdose Response Effort (KORE) funding for fiscal year 2024.

The Office of Inspector General completed 419 background checks for children & elderly services in Mason county fiscal year 2024.
