

Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

AmeriCorps has 4 members in Nelson County.

Kentucky Transitional Assistance Program (KTAP)

Your county received \$392,187 in KTAP issuance. This has been allocated to 114 households in the past fiscal year.

Health Services

Funding to Lincoln Trail District Health Department: \$4,868,280

During fiscal year 2024, in Nelson county there were 17 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.



Your county has 895 participants who received benefits totaling \$841,170.

There are 5 WIC-approved grocers in Nelson County.

Between the start of the HIV Epidemic (1982) and June 2024, there were 62 diagnosed cases of HIV in your county. (NOTE: 2023 and 2024 data is considered preliminary)

KPAP helped 168 patients in Nelson with 843 prescriptions to save a total of \$2,163,011 in prescription costs.

Division of Family Resource and Youth Services Centers (FRYSC)

Nelson County received \$591,563 in funding for 1 school district(s). The total student enrollment for schools served by FRYSC was 7,261, and 48% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$213,436.

Additional grants totaled \$20,760.

Nelson County received \$1,191,573 from the Child Care Assistance Program issuance, supporting up to 352 providers a year.

The Division of Child Support Enforcement served 2,224 children, collecting \$4,470,249 in current and past due child support, during fiscal year 2024. The agency established 2,177 orders.

There were 27 children cared for by foster families, 25 of whom received a combined per-diem totaling \$2,045.

33% of children in foster care had a goal of adoption. 66% had a goal other than adoption (e.g. reunification).

According to KASPER data, 14,185 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 37,899 of the 94,325 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 3,524 prescribers and 437 dispenser DEA numbers.

Nelson County is served by the Communicare Community Mental Health Center. Communicare received \$8,367,833 in fiscal year 2024.

Communicare served 8,252 individuals in their region in fiscal year 2024.



Nelson is located in the Communicare region. This region received \$982,617 in Kentucky Overdose Response Effort (KORE) funding for fiscal year 2024.

Public Protection Services

The Office of the Ombudsman responded to 364 constituent contacts in fiscal year 2024 in your county.

The Office of Inspector General completed 744 background checks for children & elderly services in Nelson county fiscal year 2024.
