Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

AmeriCorps has 5 members in Ohio County.

Kentucky Transitional Assistance Program (KTAP)

Your county received \$276,472 in KTAP issuance. This has been allocated to 86 households in the past fiscal year.



On average, SNAP supported 3,285 people a month in Ohio County, stretching over 1,412 households.

Funding to Green River District Health Department: \$6,620,121

During fiscal year 2024, in Ohio county there were 13 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.



Your county has 632 participants who received benefits totaling \$540,289.

Division of Family Resource and Youth Services Centers (FRYSC)

Ohio County received \$487,244 in funding for 1 school district(s). The total student enrollment for schools served by FRYSC was 3,835, and 63% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$453,720.

Additional grants totaled \$0.

Ohio County received \$443,613 from the Child Care Assistance Program issuance, supporting up to 135 providers a year.

The Division of Child Support Enforcement served 1,164 children, collecting \$1,860,723 in current and past due child support, during fiscal year 2024. The agency established 1,089 orders.

There were 59 children cared for by foster families, 52 of whom received a combined per-diem totaling \$4,286.

38% of children in foster care had a goal of adoption. 61% had a goal other than adoption (e.g. reunification).

According to KASPER data, 7,610 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 24,461 of the 57,336 total controlled prescriptions dispensed.
