


Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

AmeriCorps has 4 members in Shelby County.

Kentucky Transitional Assistance Program (KTAP)

Your county received \$273,622 in KTAP issuance. This has been allocated to 80 households in the past fiscal year.



On average, SNAP supported 2,594 people a month in Shelby County, stretching over 1,152 households.

Health Services

Funding to North Central District Health Department: \$3,152,632

During fiscal year 2024, in Shelby county there were 14 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.



Your county has 697 participants who received benefits totaling \$720,171.

There are 4 WIC-approved grocers in Shelby County.

Between the start of the HIV Epidemic (1982) and June 2024, there were 93 diagnosed cases of HIV in your county. (NOTE: 2023 and 2024 data is considered preliminary)

Division of Family Resource and Youth Services Centers (FRYSC)

Shelby County received \$704,151 in funding for 1 school district(s). The total student enrollment for schools served by FRYSC was 6,954, and 45% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$409,229.

Additional grants totaled \$78,000.

Shelby County received \$2,047,178 from the Child Care Assistance Program issuance, supporting up to 413 providers a year.

The Division of Child Support Enforcement served 1,228 children, collecting \$2,284,918 in current and past due child support, during fiscal year 2024. The agency established 1,085 orders.

There were 110 children cared for by foster families, 93 of whom received a combined per-diem totaling \$7,039.

27% of children in foster care had a goal of adoption. 72% had a goal other than adoption (e.g. reunification).

Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 13,599 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 31,171 of the 86,533 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 3,678 prescribers and 443 dispenser DEA numbers.

Shelby County is served by the Seven Counties Community Mental Health Center. Seven Counties received \$22,899,517 in fiscal year 2024.

Seven Counties served 24,161 individuals in their region in fiscal year 2024.



Shelby is located in the Seven Counties region. This region received \$5,746,244 in Kentucky Overdose Response Effort (KORE) funding for fiscal year 2024.

Public Protection Services

The Office of the Ombudsman responded to 411 constituent contacts in fiscal year 2024 in your county.

The Office of Inspector General completed 389 background checks for children & elderly services in Shelby county fiscal year 2024.
