

Serve Kentucky manages AmeriCorps programs across the entire Commonwealth of Kentucky. 696 AmeriCorps members served 670,641 hours and earned \$2,562,242 in education awards. AmeriCorps members recruited 4,213 volunteers who provided 155,955 hours of volunteer service (valued at \$4,959,369). AmeriCorps members served 74,078 students and provided food support services to 3,344 students. Serve Kentucky also provided housing services to 465 individuals and collected 153,345 pounds of food for individuals facing food insecurity.

AmeriCorps has 0 members in Trimble County.

Kentucky Transitional Assistance Program (KTAP)

Your county received \$86,992 in KTAP issuance. This has been allocated to 22 households in the past fiscal year.



On average, SNAP supported 775 people a month in Trimble County, stretching over 333 households.

Health Services

Funding to North Central District Health Department: \$3,152,632

During fiscal year 2024, in Trimble county there were 4 people enrolled in Quit Now Kentucky (no-cost tobacco quitline), QUIT Now Kentucky provided 3,947 coaching sessions across the Commonwealth.



Your county has 143 participants who received benefits totaling \$136,705.

There are 0 WIC-approved grocers in Trimble County.

Between the start of the HIV Epidemic (1982) and June 2024, there were 10 diagnosed cases of HIV in your county.

Division of Family Resource and Youth Services Centers (FRYSC)

Trimble County received \$145,876 in funding for 1 school district(s). The total student enrollment for schools served by FRYSC was 1,247, and 50% of these students were eligible for free or reduced school lunch. Donations and volunteer time totaled \$116,622. Additional grants totaled \$24,500.

Trimble County received \$118,001 from the Child Care
Assistance Program issuance, supporting up to 36
providers a year.

The Division of Child Support Enforcement served 348 children, collecting \$615,078 in current and past due child support, during fiscal year 2024. The agency established 291 orders.

There were 7 children cared for by foster families, 7 of whom received a combined per-diem totaling \$528.

28% of children in foster care had a goal of adoption. 71% had a goal other than adoption (e.g. reunification).

Kentucky All Schedule Prescription Electronic Reporting (KASPER)

According to KASPER data, 2,316 unique patients residing in your county received a pharmaceutical controlled substance. Opioid analgesics accounted for 7,554 of the 16,100 total controlled prescriptions dispensed.

Residents of your county received these prescriptions from 1,195 prescribers and 170 dispenser DEA numbers.

Trimble County is served by the Seven Counties Community Mental Health Center. Seven Counties received \$22,899,517 in fiscal year 2024.

Seven Counties served 24,161 individuals in their region in fiscal year 2024.



Trimble is located in the Seven Counties region. This region received \$5,746,244 in Kentucky Overdose Response Effort (KORE) funding for fiscal year 2024.

Public Protection Services

The Office of the Ombudsman responded to 160 constituent contacts in fiscal year 2024 in your county.

The Office of Inspector General completed 33 background checks for children & elderly services in Trimble county fiscal year 2024.
