<u>Note:</u> Effective 07/15/2018, <u>HB 444 Section 10(1)(a)</u> amended <u>KRS 216B.020</u> no longer requires RHC to be licensed or surveyed through the Office of Inspector General (OIG).

Notice to Providers:

- Provider must be actively enrolled with Medicare as a RHC at the primary physical location.
- Upon request, providers may be subject to an onsite inspection.
- IMPORTANT Providers are required per regulations to update their provider file whenever any changes are made to their enrollment information to include uploading their RHC Certification when re-issued by DHHS/HRSA.

Information about the Program:

- Provider can only be an entity, not an individual.
- Out-of-state providers may enroll.
- A valid <u>NPI and Taxonomy Code</u> registered with NPPES is required
- This provider type cannot have an active Medicaid number, if sharing the same location as an active provider group/entity. (Physician group, nurse practitioner group, physician assistant group, primary care center, etc.)

New Provider Application, Revalidation and Maintenance Information:

 All provider applications (new enrollment, revalidations, and maintenance items) are now completed using the KY Medicaid Partner Portal Application (<u>KY MPPA website</u>).

Supporting Documentation Required for New Provider Enrollment, Revalidation and Maintenance Tasks:

- <u>Clinical Laboratory Improvement Amendments (CLIA) certificate</u> (if applicable) (must be current and reflect the requested enrollment date) CLIA address must match primary physical address.
- IRS letter of verification of FEIN or official IRS documentation stating FEIN. FEIN must be pre-printed by IRS on documentation. W-9 forms will not be accepted.
- If the provider chooses to enroll in direct deposit, verification of the bank routing/accounting numbers, such as voided check or bank letter, is required.
- Pursuant to <u>42 CFR 455.460</u>, an application fee is required. Payments are processed electronically through the <u>KY MPPA website</u>. If you have already paid an application fee to Medicare or another state's Medicaid agency, payment is not required. For information regarding the current application fee, please refer to the <u>Application Fee Cabinet for Health and Family Services (ky.gov)</u>.
