SUBJECT: Substance Use Disorder Residential Certification Notification

Overview: SUD Phase II

The Commonwealth of Kentucky received approval of the 1115 Substance Use Disorder (SUD) Demonstration Implementation Plan in October 2018. The Implementation Plan includes utilizing a nationally recognized SUD program-standard to set provider qualifications for residential treatment. The Department for Medicaid Services (DMS) adopted the American Society of Addiction Medicine (ASAM) Criteria as the standard for SUD residential treatment programs.

Beginning July 1, 2021, all enrolled SUD residential treatment facilities will be required to have an ASAM Level of Care (LOC) Certification.

Provisional Certification

DMS will allow all enrolled SUD residential treatment, BHSO Tier III, providers to obtain a Provisional Residential LOC Certification by Self-Attestation. If you are a BHSO Tier one (1) or Tier two (2) provider this does NOT apply to your services. All facilities that receive a Provisional Certification will be eligible to receive a waiver of the IMD exclusion to provide up to 96 treatment beds per Medicaid identification number. Provisionally certified providers may also be eligible to receive an enhanced rate for residential services rendered during the provisional period.

Self Attestation

Providers will submit an attestation to DMS.

DMS Desk Audit

 DMS will utilize a checklist outlining the ASAM criteria by residential levels to review completed attestations.



Provisional Certification

- Upon review of the all attestations, DMS will issue a letter of Provisional approval to each facility that submitted a complete Attestation containing a Provisional Certification.
- Provisional certification will be effective April 1, 2020 (or later approved date), with expiration June 30, 2021.
