What Waiver Services Mean to Me: Anthony Brettnacher

When Anthony Brettnacher received the opportunity to be a Make-A-Wish kid more than five years ago, he could have chosen a trip to Disney, a meeting with a celebrity, or another once-in-a-lifetime experience. If he had, who could blame him? Those all sound like a lot of fun. Instead, Anthony, now 12, decided to use his wish on something that would bring joy to himself and his friends for many years to come. In 2022, after delays caused by the COVID-19 pandemic, his wish became a reality when a new accessible playground opened at the Kentucky School for the Blind (KSB) in Louisville.

Anyone who knows Anthony isn't surprised by his generosity and care for others. Affectionally named the "Mayor of the Kentucky School of the Blind", the sixth grader is a popular figure on campus due to his outgoing demeanor and loves to make friends wherever he goes. Anthony is visually impaired due to brain damage caused by a benign brain tumor, which doctors discovered when he was two years old. Following emergency surgery on the tumor, Anthony suffered a stroke and lost his vision. He also has limited use of the left side of his body and other medical conditions.

In addition to attending KSB, Anthony receives services through Kentucky Medicaid's Home- and Community-Based (HCB) waiver. His mother, Cierra, began researching the waiver programs at the suggestion of a case manager at Frazier Rehabilitation Hospital in Louisville. Anthony started receiving HCB services three years ago. The whole family has benefitted from the support.

"It has made a huge difference in quality of life for both Anthony and myself," says his mother, Cierra.

The HCB waiver helped cover the cost of a ramp for the family's home, making it easier for Anthony to get in and out of the house in his wheelchair. Anthony and Cierra also expanded his care team by using the Respite service.

"It allows me to have much-needed time not focusing on Anthony and being able to take care of myself," says Cierra.

Building a community of support around Anthony is important to Cierra and a goal they are constantly working toward.

"I also am a huge supporter of networking, building our village. In our case specifically, this includes building relationships with adults who have various disabilities (especially blind adults), so that he and other kids have role models who accurately reflect what is possible in their future," says Cierra.

Their network building isn't just beneficial to them, it helps others too.

"I had two moms I have become friends with ask me for favors, nothing big, but it helped them tremendously. And I know I can always ask them for favors. We help each other make it all work. And we can lean on each other when it gets tough and emotional," says Cierra.

Their experience finding the HCB waiver, and knowing how much it can improve quality of care, now compels both Anthony and Cierra to

advocate for all individuals and families. Cierra often shares her knowledge with fellow special needs families. She has served as president of the Parent, Student, Staff Organization at KSB, and as a parent advocate for students who need individual education plans and their families. Both Cierra and Anthony have also appeared in Frankfort numerous times to advocate. Cierra is very excited about the recent Children's Waiver Feasibility Study and the potential for home- and community-based services targeted specifically to children.

Cierra's biggest piece of advice for families in a similar situation is to learn as much as they can about the diagnosis and the resources available to help.

"Diagnoses can be scary, it can be overwhelming to navigate the medical world and the resources available. The best thing you can do for the person you are caring for is educate yourself. And the best way to educate yourself is to ask questions. Don't be afraid to ask questions at doctor appointments, ask your case manager if there is something that you aren't currently taking advantage of, utilize social media to find people in similar situations and ask questions, use the CHFS website. And of course, build your village," says Cierra.

Anthony and Cierra continue to find new and exciting ways to build his village. In the spring of 2023, Anthony joined a Miracle League Baseball program in Louisville. The league gives children with physical, cognitive, and/or emotional disabilities an opportunity to play an organized sport.

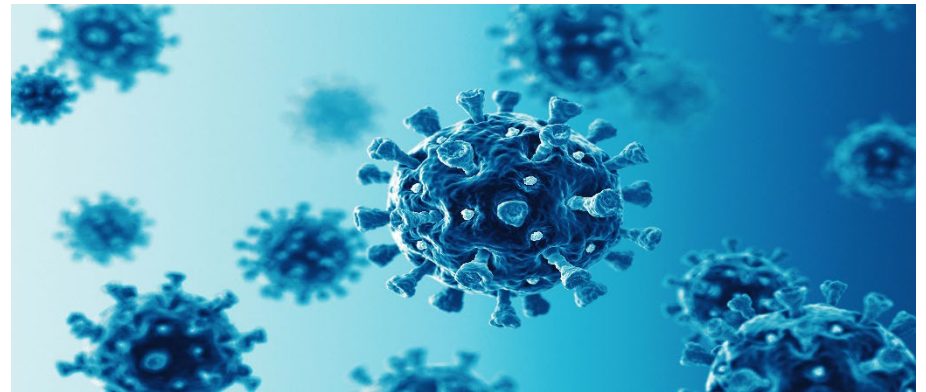

Appendix K to End May 1, 2024

Kentucky's COVID-19 Appendix K amendment is scheduled to end soon. The Department for Medicaid Services (DMS) received approval for multiple Appendix K amendments between 2020 and 2023 to help providers and participants through the challenges of the COVID-19 public health emergency. In November 2023, DMS submitted updated waiver applications to the Centers for Medicare and Medicaid Services (CMS) to make some Appendix K changes permanent. CMS recently approved the updated waiver applications with an effective date of May 1, 2024. **This means any Appendix K policy that is not included in the updated waiver application will end on May 1, 2024.** DMS has several resources available for stakeholders about which Appendix K flexibilities will become permanent and which will end.

Model II Waiver (MIIW) Approval

The updated MIIW application took effect on February 1, 2024, after receiving approval from CMS. In the case of MIIW, DMS only made updates to ensure the temporary 50% Appendix K rate increase continued. Any provider billing the 50% rate must submit a Rate Increase Attestation Form to DMS and pass through 85% of the increase to direct care staff. The rate increases will remain in place until the implementation of the rate methodology study developed during the 1915(c) waiver rate study and subsequent budget allocation.

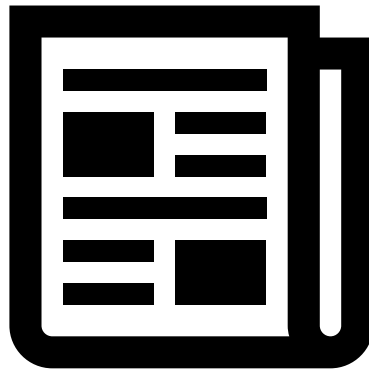
The amended waivers include some policies that DMS will begin to implement after May 1, 2024. More information will be shared soon.

Changes Coming to EVV – Provider Action Needed



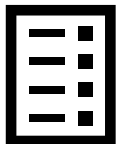
In 2021, DMS implemented electronic visit verification (EVV) for most 1915(c) HCBS waiver programs. EVV is used to capture data about in-home service visits electronically. A complete listing of services required to use EVV is available at <https://bit.ly/kyevvservices>. EVV is a requirement of the federal 21st Century Cures Act. In 2024, DMS plans to transition the vendor

for the state-sponsored system from Netsmart to Therap. Therap currently supplies the state-sponsored EVV system for MIIW, Home Health, and Private Duty Nursing services. DMS implemented EVV for those providers in 2023. Waiver Service Spotlight – Goods and Services



There are many services available through 1915(c) HCBS waivers to help participants progress toward increased independence in the home and promote community inclusion. One of these waiver services that help participants meet person-centered needs and goals is called Goods and Services. When utilizing Goods and Services, there are some important points to remember. Any good or service must:

- Be linked to a participant's person-centered need identified through the completed waiver-specific assessment, reflected in the participant's person-centered goals and objectives, and documented in the person-centered service plan.
- Reduce the participant's need for other Medicaid services, promote inclusion in the community, enhance independence, and/or increase participant safety in the home environment.

Goods and Services are available to waiver participants for items and/or services meeting the criteria above, that cannot be accessed or obtained through Medicaid state plan benefits. Many goods and services are covered by the state plan and can be found using the appropriate fee schedule at <https://bit.ly/KYDMSFeesandRates>. An example of a state plan benefit that can be utilized by waiver participants under the age of 21 is Medicaid's Early and Periodic Screening, Diagnostic, and Treatment (EPSDT) benefit. All waiver participants can request state plan services in addition to waiver services already being accessed.
