## **Provider Category-Provider Type # Cross Reference**

A Medicaid Provider is an Individual, Group, or Entity that assists Medicaid recipients by providing medically necessary services. Provider application requirements will vary depending upon the specific provider type of the Medicaid Provider. Examples of requirements include required forms, certifications/licenses, supporting documentation, in-state/out-of-state, and sometimes, even age of the provider.

## **Provider Categories**

An **Individual Provider Type** is for those providers who work for themselves. Examples include Physicians, Dentists, Optometrists, and Chiropractors. A list of Individual Provider Types is included in **Figure 1**.

A <u>Group Provider</u> is an organized Group, which has within its bounds multiple Providers and sometimes multiple services. Examples include Physician Group, Dentist Group, Optometrist Group, and Chiropractor Group.

**Note**: Many provider groups reflect individual provider types. For example, Provider Type 85 is a Chiropractor; Provider Type 859 is a Chiropractor Group.

An <u>Entity Provider</u> is a health related organization, such as a clinic, hospital, or nursing facility.

A list of Group/Entity Provider Types is included in Figure 2.

To view the specific requirements for each provider type, view the associated provider type summary.

**Note**: For Group/Entity Provider Types 509-959, the provider summaries on the <u>Provider</u> <u>Enrollment web page</u> list a three-digit code for the provider number. However, the applicant will need to select the two-digit code listed within KY MPPA.
