OVERVIEW

In 2023, the Kentucky Department for Public Health (KDPH) was awarded the First Responders-Comprehensive Addiction and Recovery Act (FR-CARA) Grant by The Substance Abuse and Mental Health Services Administration (SAMHSA). The goal of the FR-CARA Grant in Kentucky is to expand naloxone training and dispensing for first responders throughout rural counties and to increase awareness for ongoing harm reduction activities and personal safety measures for opioid exposures.

ELIGIBLE AGENCIES

- · Park Ranger Services
- Quick Response Teams
- Search and Rescue Teams
- Public Safety Offices (College, K-12 Schools, Universities)

To receive naloxone through the FR-CARA Grant, all first responders from requesting agencies must be trained to administer the drug. Training focuses on how opioids and naloxone work, relative risks of fentanyl exposure, risk factors for opioid overdose, how to recognize/respond to an opioid overdose including how to administer naloxone and properly store. An instructor-led class offering first responder training credits is available through online KY TRAIN or by live zoom from the Kentucky Pharmacists Association. Training can be requested by submitting the Naloxone Request Form in the section below.

REQUESTING NALOXONE

First responder agencies can request naloxone and training by utilizing the following process:

Step 1:

Step 2:

Fill out the Naloxone Request Form completely and be sure to indicate if training is being requested for staff.

Step 3:

KDPH personnel will review the request and forward to KPhA for approval and dispensing.

Step 4:

Approved naloxone requests will be shipped to the requesting agency or partnering LHD, if required.

REPORTING NALOXONE USAGE

Agencies that receive naloxone through the FR-CARA Grant must adhere to reporting requirements to support the program's goals, objectives and continued funding. Agencies will report naloxone usage/distribution by following agency-specific protocols AND by completing the Naloxone Data Collection Form using the following link, QR Code or by emailing a written report to
