




2019-2020 Total Laboratory *Confirmed Influenza Cases in Kentucky, by Age




Total 2019-2020 Influenza Virus Types Reported in Kentucky




2019-2020 Total Laboratory *Confirmed Influenza Cases in Kentucky, by Reporting Week






2019-2020 Total Laboratory *Confirmed Influenza Cases in Kentucky, by Age




Total 2019-2020 Influenza Virus Types Reported in Kentucky






2019-2020 Total Laboratory *Confirmed Influenza Cases in Kentucky, by Age




Total 2019-2020 Influenza Virus Types Reported in Kentucky






