Additional Indicator Information For Indicator 3:

The Early Childhood Outcomes are not included in the overall score for the district. Instead, a comparison of the scores from the current and prior year is presented to visually show if the district is making improvement.

For Indicators 4, 5, and 6: The COVID-19 pandemic impacted performance for FFY 2021. For much of the year, services were only offered by tele-intervention. Referrals were down due to fear of the virus and closure of referral sources. These factors were out of the district's control. The results for these indicators are not comparable to prior years and were not included in the overall score for the district for FFY 2021.

The Lincoln Trail District has scored in the Meets Requirements category for the 4th year.

A determination of **Meets Requirements** means that the district is in compliance in meeting the state targets. This may include correcting any identified non-compliance within one year of notification to the district. The district is not subject to any enforcement action by the state.
