Northern Kentucky District Determination

The Northern Kentucky District has scored in the **MEETS REQUIREMENTS** category for the 9th year.

A determination of **MEETS REQUIREMENTS** means that the district is in compliance in meeting the state targets. This may include correcting any identified non-compliance within one year of notification to the district. The district is not subject to any enforcement action by the state.

Indicators 1, 7 and 8 are compliance indicators. The target is set by the Office of Special Education Programs (OSEP).

For Indicators 4, 5, and 6: The COVID-19 pandemic impacted performance for FFY 2021. For much of the year, services were only offered by tele-intervention. Referrals were down due to fear of the virus and closure of referral sources. These factors were out of the district's control. The results for these indicators are not comparable to prior years and were not included in the overall score for the district
