Kentucky National Background Check Disqualifying Offenses

Pursuant to 906 KAR 1:190, Section 1(4), a "disqualifying offense" is:

- Identification on the Kentucky Nurse Aide Abuse Registry, Kentucky Child Abuse and Neglect Central Registry, Kentucky Caregiver Misconduct Registry, Federal List of Excluded Individuals and Entities (LEIE), or any available abuse registry, including the abuse and neglect registries of another state;
- A crime described in 42 USC 1320a-7;
- A substantiated finding of neglect, abuse, or misappropriation of property by a state or federal agency pursuant to an investigation conducted in accordance with 42 USC 1395i-3 or 1396r;
- Registration as a sex offender under federal law or under the law of any state;
- An offense under a criminal statute of the United States or of another state similar to an offense listed in this document;
- A conviction of, or a plea of guilty, an Alford plea, or a plea of nolo contendere to:
 - o A misdemeanor offense related to:
 - Abuse, neglect, or exploitation of an adult as defined by KRS 209.020(4);
 - Abuse, neglect, or exploitation of a child;
 - A sexual offense;
 - Assault (including domestic violence) occurring less than seven (7) years from the date of the criminal background check;
 - Stalking occurring less than seven (7) years from the date of the criminal background check;
 - Theft occurring less than seven (7) years from the date of the criminal background check;
 - Fraud occurring less than seven (7) years from the date of the criminal background check;
 - Unlawfully possessing or trafficking in a legend drug or controlled substance occurring less than seven (7) years from the date of the criminal background check; or
 - Any other misdemeanor offense relating to abuse, neglect, or exploitation not listed and occurred less than seven (7) years from the date of the criminal background check;
 - KRS 525.130, Cruelty to animals in the second degree Exemptions Offense involving equines;
 - Any other misdemeanor offense relating to abuse, neglect, or exploitation that is not listed
 in this subsection and occurred less than seven (7) years from the date of the criminal background check;
 - o A criminal offense against a victim who is a minor, as defined in KRS 17.500;
 - o A felony offense involving a child victim;
 - A felony offense as described in the following table:

An out-of-state or federal charge that is pending or any outstanding warrant from another state or jurisdiction that is similar to an offense specified noted above.

A crime described in 42 U.S.C. 1320a-7

A substantiated finding of neglect, abuse, or misappropriation of property by a state or federal agency pursuant to an investigation conducted in accordance with 42 U.S.C. 1395i-3 or 1396r; Registration as a sex offender under federal law or under the law of any state; or Being listed on a registry as defined in 906 KAR 1:190, Section 1, subsection 10.
